






## **FARM STRUCTURE (2)**

Agricultural holdings, AWU by economic size classes, Republic of Serbia, 2012



Largest number of AWU is in the economic size group 4000 – 8000.




According to AC in Republic of Serbia, major agricultural holdings had the economic size up to EUR 8,000 (almost 86%), they use 38% UAA and about 40% LSU.

SO per holding by main types of farming, Republic of Serbia, 2012




The highest average SO per holding by type of farming in 2012 was on holdings specilized in horticulture (almost EUR 11,000), and in specialized field crops holdings (more than EUR 8,000)

According to the graph, in 2012 the largest share of holdings in Republic of Serbia is in mixed crops-livestock farming (about 31%). The next group by the number of holdings is specialist field crops (about 20%).






